**Re.: Update on disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

This is in continuation to our earlier letter dated March 7, 2024, December 24, 2024 and March 31, 2025 regarding acquisition of up to 28% stake i.e. 64,575 CCDs of face value of Rs. 1,000/- each & 37,92,500 Equity shares of face value of Rs. 10/- each in O2 Renewable Energy XVIII Private Limited ("O2") for the purpose of accessing renewable power of 6.41 MW through captive arrangement and Inter State Transmission System (Round the Clock) for meeting the captive requirement as defined under the Electricity Rules, 2005 for meeting the green energy requirements of Company's manufacturing facilities located at Gajraula, Uttar Pradesh & Savli, Gujarat.

The details for the above acquisition as required pursuant to Regulation 30 read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13 July 2023, have already been disclosed in the intimation dated March 7, 2024.

In this regard, please be informed that up till April 25, 2025, the Company had acquired 36,02,875 equity shares of face value of Rs. 10/- each and 61,346 CCDs of face value of Rs. 1,000/- each in O2 and the acquisition of remaining stake is likely to be completed by June 2025
