

Subsequent exposure may cause severe allergic reactions of the skin, eyes and respiratorytract. Ingestion of formaldehyde can be fatal, and long-term exposure to low levels in the air or on the skin can cause asthma-like respiratory problems and skin irritation such as dermatitis and itching. Concentrations of 100 ppm are immediately dangerous to life and health (IDLH).
- . Note: The National Institute for Occupational Safety and Health (NIOSH) considers 20 ppm of formaldehyde to be IDLH.

#### Chronic effects:

 Chronic exposure to formaldehyde was related to episodes of aphonia and pharyngeal irritation (laryngeal mucosa and vocal cords were swollen) that disappeared when occupants were away from work ... Neurobehavioral effects, such as headache, dizziness, nausea, memory loss, and sleeping problems were also observed among histology technicians exposed to concentrations from 0.2 to 1.9 ppm.

# **Extinguishing media**

• Appropriate extinguishing media: Water fog, alcohol resistant foam, dry chemical or carbon dioxide extinguisher. Water may be ineffective. Use water spray to keep fire exposed containers cool. ## **Special Protective Equipment and Precautions for Fire Fighter**

- Evacuate the area and fight fires from a safe distance.
- If tank, rail car or tank truck is involved in a fire, ISOLATE for 800 meters (1/2 mile) in all directions; also, consider initial evacuation for 800 meters (1/2 mile) in all directions or as per locally valid procedures.
- Fire fighters must wear Self Contained Breathing Apparatus (SCBA) and full protective clothing.
- Report any run-off of fire waters contaminated with this chemical as per local and federal procedures applicable.

#### Unusual fire and explosion hazard

- Consider isolating the fire when it involves the material and permitting it to burn itself out. Move all personnel out of the fire area. Move away in event of any explosion. Keep at safe distance.

#### 8.2 Exposure controls

**Appropriate Engineering Controls:** Provide exhaust ventilation or other engineering controls to keep the relevant airborne concentrations below their respective occupational exposure limits.
